1 **DECLARATION OF KATHLEEN PORTER**

2 I, KATHLEEN PORTER, declare and state as follows:


3 1. I am Senior Vice President of Finance at Live Nation Entertainment, Inc. ("Live
4 Nation"). I have personal knowledge of the following facts, and would testify competently thereto
5 under oath if necessary. I am submitting this declaration in support of Ticketmaster's Memorandum in
6 Support of Motion for Final Approval of the Proposed Class Action Settlement Agreement.

7 2. In my position as Senior Vice President of Finance at Live Nation, I have access to
8 database information about the ticket prices charged at various events hosted at Live Nation owned
9 and operated venues. I have reviewed reports from the applicable database and confirmed that the face
10 price of tickets for general admission lawn seats at Live Nation owned and operated events between
11 2010 and 2014 has been in an average annual range of between \$22.36 and \$24.35. Taking a total
12 average over that period yields an average face ticket price of \$23.61.

13 3. The Ticketmaster service fees that would have been charged on the face price of such
14 tickets would have been approximately \$9.00, excluding potential additional fees for things like
15 parking, facility fees and charity.

16 I declare under penalty of perjury under the laws of the State of California that the
17 foregoing is true and correct.
