2 **PLEASE TAKE NOTICE** that on January 13, 2015, at 10:00 a.m., or as soon thereafter as
3 the matter can be heard in Dept. 310 of the above-entitled Court, located at 600 South
4 Commonwealth Avenue, Los Angeles, California 90005, Class Counsel will move the Court for an
5 Order awarding to Plaintiffs and Certified Class Representatives Curt Schlesinger and Peter Lo Re
6 an incentive payment in the amount of \$19,000 each, and Plaintiffs and Certified Class
7 Representatives James Roth, Adam Russell and Maryam Aghchay (collectively, the "Plaintiffs") an
8 incentive payment in the amount of \$500 each. The total amount of the incentive awards sought is
9 \$39,500.
